





How we get there


The island is one of the Leeward Islands in the Lesser Antilles. It is situated about 2,100 km (1,300 mi) southeast of Miami, Florida. The land area of St. Kitts is about 168 km² (65 sq mi), being approximately 29 km (18 mi) long and on average about 8 km (5.0 mi) across. St. Kitts is easily reached from the United States, Canada, the United Kingdom and United Emirates and the rest of Europe. A wide range of international scheduled airlines and charter carriers serve the island regularly.

About St. Kitts General Information

Saint Kitts (also known more formally as **Saint Christopher Island** and *Saint-Christophe* in French) is an island in the West Indies. The west side of the island borders the Caribbean Sea and the eastern coast faces the Atlantic Ocean. Saint Kitts and the neighboring island of Nevis constitute one country: the Federation of Saint Kitts and Nevis.

The capital of the two-island nation, and also its largest port, is the Town of Basseterre on Saint Kitts. There is a modern facility for handling large cruise ships there. A ring road goes around the perimeter of the island with smaller roads branching off of it; the interior of the island is too steep for habitat. Saint Kitts has a population of around 35,000, the majority of whom are mainly of African descent. The primary language is English, with a literacy rate of approximately 98%. Residents call themselves Kittitians and Nevisians. Currency: the stable currency the eastern Caribbean dollar (EC\$) is pegged to the United States dollar has remained the same rate of exchange at (EC2.70) to the US\$1.00 since 1976.





Why St. Kitts

St. Kitts is strategically and uniquely located. Easy access to major international airports which make it an easy to get to destination. St. Kitts is 3 hours from Miami, 4 hours to New York and 8.5 hours from London. The island offers sunny and cheerful climate year round.

The island of Saint Kitts is home to the Warner Park Cricket Stadium which was used to host 2007 Cricket World Cup matches. This made St. Kitts and Nevis the smallest nation to ever host a World Cup event. Saint Kitts is also home to several institutions of higher education, including Ross University School of Veterinary Medicine, Windsor University School of Medicine and the International University of Health Sciences.
